- 1. The Church continues to experience solid financial performance. Pledge revenue continues to be above budget while expenses are running below budget. We ask that members try to keep their pledge current during the summer.
- 2. Akita had a successful and safe summer. Approximately 1500 campers attended. Consider reviewing the Akita Sunday services which is available on the website.
- 3. The Board formally endorsed the New Horizon Capital Campaign. The goal is to retire the debt left over from the Realize campaign. Ginny Barney will chair the effort.
- The Board received an update on the various Strategic Planning Operational Initiative Teams. All the teams have started their work. The Board will be receiving regular updates on their progress.
- 5. As we head into fall, nominations for Governing Board and the Diaconate will be sought by the Nominating Committee. Also, the Governing Board Nominating Committee will be seeking names for nomination for the Nominating Committee. More information will be forthcoming about the process.

OPENING/CALL TO ORDER

Chairperson Cydney Philbin called the meeting to order at 7:04 pm. Pam Shisler gave the opening prayer.

There was sharing of joys and pastoral concerns by Board members.

For the Building Community First, Cydney called on each member to tell what committees, councils, and boards they participate in, and whether they meet in person or virtual.

APPROVAL OF JUNE 2021 MINUTES

Dick Wood, Jr. made a motion to approve the June 25, 2021 meeting minutes. April Howe seconded the motion, and the motion passed unanimously.

REPORTS

Cydney called on Glen Miles who highlighted a few items in his report, including the Kickoff Sunday and Dedication Sunday. He also updated the Board on new personnel that will be starting in September.

Cydney called on Paul Anderson who mentioned a few items from his report. He reported on the challenges in filling open teaching positions for MECDC and for Akita facilities and kitchen. The lack of adequate staff may cause us to suspend food service for Akita rental groups. Paul also mentioned that we are moving to a mandatory COVID vaccine policy. Currently, there are 3-4 staff that are holdouts, most of whom work with our children. He briefly touched on the financial results for July.

Alice gave a brief update from the Personnel Committee, which was held prior to this meeting. Health insurance has been renewed at no additional cost and short-term disability insurance has been added as a benefit. The cost of the short-term disability insurance will be offset by a reduction in accumulated sick time.

UNFINISHED BUSINESS

Cydney then called on Glen who introduced Ginny Barney. Ginny has agreed to chair the New Horizons capital campaign. Glen then offered some introductory comments about the history of previous capital

campaigns, the status of First Community and the need now for the capital campaign. Ginny then reviewed the process and timeline for the New Horizons campaign. She also introduced Bruce Pontious who will serve as campaign consultant.

Ginny then made an ask of the Governing Board to consider a personal pledge to the campaign. She emphasized the need for 100% participation by the Board. Pledge cards were then distributed to the Board. She then answered a few questions from the Board.

Motion made by Joe Bull and seconded by Deb Humphrey to move that the Governing Board endorses the New Horizons capital campaign and approve the following individuals to serve on the steering committee:

Dear Members and Friends:

I hope that you are enjoying the summer, a return to gatherings with friends and family, and are attending First Community activities. Below is a brief update on our financial and operational performance. You can access our financial dashboard and other Governing Board documents by clicking <u>here</u>.

Through June, we continue to perform well. A few highlights for you:

- We are grateful for all who have prepaid their pledge or are staying current. Through June, our pledge revenue is \$187k above budget. We think this is a timing variance and expect pledges to track closer to budget as we go into year-end.
- Fee-supported revenue is also above budget, primarily as a result of Mary Evans Child Development and the Early Childhood programs receiving state assistance for COVID-related expenses. Tuition revenue from both programs, as well as Akita camper fees, are above budget for the year.
- Gifts and other support consist of several grants and bequests. The First Community Foundation has provided \$330k of grants to the Church in 2021 thus far. These grants have provided Camp Akita with a tent, several vehicles, and reimbursed pandemic-related expenses necessary to operate safely. Grants have also allowed new painting, flooring, and carpeting on the second floor of South, the new wall in the Weist Room, a piano for South, and the replacement of HVAC units.
- Our expenses are running close to budget. There are some budget overages in Akita, but most of these are the frontloading of expenses in preparation for summer camp. We have incurred a string of emergency repairs to HVAC systems, roof leaks, and major renovation of the North cooler, which have also caused some variances in facility costs. The staff continues to do a good job of controlling their spending, which is challenging as we begin more in-person programming and meetings.
- Our cash position remains very good, although we expect it to decline as we go through summer. Historically, September is when our cash position will be at the lowest.
- Our debt related to the new construction remains unchanged at \$5.7m. The collection of the remaining pledges should reduce this to below \$4.5m, and a committee has been formed to look at how to eliminate the debt.

We utilize a forecast that is reviewed monthly with the Finance Committee. We believe our assumptions are conservative and reflect that we should be able to achieve our 2021 budgeted operating results. We also will have some necessary capital expenditures this fall, such as replacing the Grace Hall HVAC and improvements to the security of the Early Childhood space. Funding for these has not been identified.

Paul Anderson, our Executive Director of Operations, has taken on other reviews with the oversight of the Finance Committee. A third party has looked at our insurance coverages, and we have implemented banking tools to reduce external fraud. Currently in-process are changes to donor restricted accounting to align with best practices and ensure that donor intent is always followed. We also continue to assess any potential hacking threats to our IT systems.



We are pleased with the results so far in 2021, despite the handicaps of the pandemic. We are thankful for the generosity of our members. Please reach out to Paul Anderson (Paul's email) or me (Jason's email) if you have questions or concerns. You can also call the Church to reach us.

Older Adult Council Liaison Report 8/25/21

The Older Adult Council is a dedicated group of our older FC members, who gather for fellowship, education and to organize outreach to the FC Older adult membership. They meet once a month (except in the summer) with Robin Hood and Jim Long as their staff liasions. With Jim's retirement horizon, he seems to be phasing out of this role and Robin is doing a nice job of filling that role. This group has a chair person(s) and currently 13 members, each of whom has committed to a three-year term.

The Older Adult Council recently defined their purpose statement as the following:

It shall be our purpose to:

- 1. Search for innovative forms of ministry that focus on older adults.
- 2. Provide opportunities for learning and spiritual growth.
- 3. Provide an environment for social interaction.
- 4. Serve as an agent for communication, outreach, and advocacy.

With this purpose in mind, this group is true to their calling. They try to include an element of education with guest speakers at their meetings and recently explored an education series titled "Elements of Engagement". They look for ways to engage and provide outreach to our older adults. This year they have planned an older adult fall trip to Akita, and wrote welcome notes to new members.

More importantly, these council meetings provide social interaction and an opportunity for small group ministry. This council spends time sharing updates on friends and members who may be going through health issues. The pandemic made traditional in person meetings hard for this group, so they have adapted to a new Zoom meeting style, and are working on some new computer skills!

As we look forward at the evolution of our Governance structure, this Council seems to function more as a small group education/ministry forum rather than an activity-focused group. The members are interested in furthering their older adult experiences within the church, but also just seem to enjoy the opportunity to gather in their small group. Robin Hood does a great job facilitating their meetings and providing staff support. They typically have about 8-9 members at every meeting and spend a good portion of their meeting time "catching up". This group is always very interested in the Governing Board report as it sparks debate and discussion.

Summer 2021 Deacon's Report.

The June 15th 2021, Deacon's meeting was the Annual Deacon's Picnic, held this year at the Jim Long residence. With almost a 100 percent attendance: fun, dinner, and an instructional communion serving session was included, as well as a message from Dr. Miles. We now have two deacon's classes that have had little interaction with the church members in terms of communion services, baptism, new members classes or condolence interaction with members. These areas will be addressed this fall as we hopefully begin to open up to more direct contact with FCC members. Additionally, we will look forward to a long-honored tradition of Deacon's contacting long term members over the holiday period with notes and personal visits as part of the FCC relationship with our members. Regular monthly meetings will resume in September, and the process of making the Communion services in the new sanctuary a significant and workable part of worship, will be on the agenda.
