REPORTS

Glen Miles gave a brief update to his written report. He updated the Board on the Short-Term Task Force meeting held early in the day. He also asked the Board to comment in Facebook when watching online.

Paul Anderson then updated his written report by discussing the rollout of the mobile app, the upcoming decision on Akita, preparations for re-opening buildings and briefly on the financial situation of the Church. He then answered several questions on sanctuary offerings and the draw on the line of credit.

UNFISHISHED BUSINESS

Jodi stated that the Governance Review and Strategic Planning are both on hold.

NEW BUSINESS

Steve Mushrush made a motion to ratify the electronic vote on the Payroll Protection Program loan/grant. Cydney Philbin seconded the motion and it passed unanimously.

First Community Church Governing Board Meeting Key Takeaways April 22, 2020

- A task force made up of members of the Governing Board, lay leaders and staff has been formed with the purpose of looking at the ministry and programming needs on a short-term basis. The task force will meet several times over the next 2-3 weeks to make recommendations on how our ministries will evolve as the stay in order is gradually lifted.
- Financially, the church is stable. We were able to obtain a loan under the Payroll Protection Program of the CARES act. This will assist us to keep our staff employed for the time being, even without the Mary Evans and Early Childhood programs operating. The loan can convert to a grant based on achieving certain metrics. Members are encouraged to keep their pledge current, if possible.
- The Clergy and Program staff are hard at work and have evolved to a virtual ministry. Most Councils and Boards have met utilizing video or phone conferencing. Programs such as Dr. Mile's bible study, adult education, Crossroads, choir rehearsals and other programs are active and meeting utilizing technology. Pastoral care continues without social contacting.
- There is an emphasis on connectivity. We continue to call approximately 700 of our more senior members. An effort is underway by a group of 110 volunteers to call every member of First Community.
- The mobile app will be rolled out on April 24th. It will allow on-line giving and be linked to a member giving records. It will also allow for text giving, registrations and provide another means for announcements. As part of this effort, we will be communication with all members to update their membership records. We have found our records dated as people have changed e-mail addresses, dropped land phone lines, changed mobile numbers or have even moved without notifying the Church.
