



Governing Board Key Takeaways October 28, 2020

- Revision to the constitution were reviewed and voted on. The revisions were passed unanimously by the Board. An informational meeting about the changes will be help via Zoom on Monday, November 16<sup>th</sup>. Look for more information in the Church weekly email.
- 2. The Board passed a safe church policy detailing guideline for volunteers that work with children. This is very common and has been implemented by most large churches. Member of the Youth staff will be reviewing the policy with volunteers to clarify the policy and answer any questions.
- 3. As of September 30<sup>th</sup>, the financial position of First Community was stable. The Bridge matching special ask was very successful, and the match was met. This will go a long way in helping our results for 2020. The current forecast is if pledges continue to be paid as they have been all year and if there continues to be good cost controls, we may come close to break even for the year.
- 4. The 2021 stewardship campaign is nearing completion. Pledges are slower in being returned this year. Compared to the past year, we are about one week behind. 100% of the Governing Board made a pledge for 20021 prior to the kickoff on October 4<sup>th</sup>. Everyone who has not done so is urged to go on-line to pledge or request a pledge card from the Business Office.

#### **OPENING/CALL TO ORDER**

Jodi Patton, Chair called the meeting to order at 7:05. Molly Hagkull gave the opening prayer. Jodi then led the Board in a community building exercise by asking amid the pandemic what do you relish the most? She then called on attendees to respond. There was then a sharing of joy and pastoral concerns.

#### **APPROVAL OF SEPTEMBER 23, 2020 MINUTES**

Cydney Philbin made a motion to approve the September 23<sup>rd</sup> board minutes as presented. It was seconded by Joe Bull and passed unanimously.

#### **REFLECTION/ANNOUCEMENTS**

Jodi reported that there is 100% participation in the 2021 stewardship campaign. She thanked the Board for their participation in so many ways. Jodi the reminded the Board of the combination of the November and December Board meeting on December 9, 2020. She also highlighted the December holiday party that we are still hoping to hold in person. She then thanked Dr. Miles, Paul Anderson, Liz Compton, and the Finance Committee for their work so far on the 2021 operating budget.

#### REPORTS

Dr. Miles offered a correction to his report and highlighted several items in his report regarding Advent and other upcoming activities. He mentioned the work of the Financial Review Task Force has started with the goal to bring more clarity to our financial position. Scott Glaser, Larry Anderson, Jodi Patton, Jason Milligan, Paul Anderson, and Glen Mile serve on this task force.

Paul Anderson then did a brief review of the September 2020 financial dashboard and an outlook for October. He then reviewed his operational report. Paul also mentioned the challenges we have had in streaming Sunday morning worship over the past few weeks. He told the Board that both a short term and a longer-term solution are in the works.

#### UNFINISHED BUSINESS

**Governance Review-** Jodi called on Cydney Philbin who is chairing the Governance Review Task Force's work to update the constitution revisions. Other members of the Task Force are Elizabeth Downey, Pam Shisler, Steve Mushrush and Paul Anderson. Cydney then presented the changes to the revisions since March 2020. Cydney made a motion to adopt the changes as presented and it was seconded by Alice Finley . Motion passed unanimously. A brief discussion about the planned congregational informational meeting on November 16<sup>th</sup> was then held.

**2020 Strategic Plan** – Jodi then called on Pam Shisler who provided an update on the strategic planning process. A meeting was held with Reverend Sarai Rice, our facilitator, and the planning committee early this past week. Reverend Rice outlined some work for the planning committee. The planning committee consists of Terry Davis, Carrie Schwab, Catherine Adams, Cydney Philbin, Randal Ott Espinoza, Jamie Green, Glen Miles, and Paul Anderson.

**Nominating Committee Candidate Process** – Jamie updated the Board on the process for nominations to the Nominating Committee. Of this list developed from names nominated by the Governing Board, 9 were excluded by applying the same vetting process as nominees for Governing Board and Board of Deacons. A brief discussion was held regarding why these individuals were not making a gift to the operating fund of the church. It was agreed that a discussion will be held in the future on why some in leadership roles at First Community do not contribute. Jamie will share the list of nominees with the Board and will begin the process of contacting nominees for their acceptance to run. 24 nominees are needed.

#### **NEW BUSINESS**

**Safe Church Policy** – Cydney, as chair of the Personnel Committee, ask Paul to present to the Board the process for development of the Safe Church Policy. The policy was developed by the Youth Team, Carrie Schwab, and Paul Anderson. It was then reviewed by both our legal counsel and insurance carrier. The policy was also reviewed against policies of other large churches. A discussion was held, and several questions were poised to Paul. Cydney then made a motion to adopt the policy as presented, and it was seconded by Stacy McVey. The motion passed unanimously.

**Other** – A brief discussion was held about how to show appreciation to the Foundation for the support they have shown to the Church. Jodi asked Alice Findley to determine an appropriate means to thank the Foundation. Glen said he would also send individual notes to the Foundation Board members.

#### FULL BOARD CLOSING

Glen Miles offered a closing prayer. At 8:31 pm, Jodi then excused the guest and the 2<sup>nd</sup> year class.

#### **EXECUTIVE SESSION**

It was then moved and second to go into executive session without the 2<sup>nd</sup> year class. Motion to do so passed unanimously. Jodi asked Glen Miles, Paul Anderson, and Jason Milligan to also attend. After a discussion, a vote was taken to elect a vice chair for the 2021-2022 year. After the vote, Jodi agreed to



call the 1<sup>st</sup> and 2<sup>nd</sup> choice and report back to the Board. There was then a motion and second to leave executive session. The motion then passed unanimously.

Jodi thanked the remaining attendees for their participation and then adjourned the meeting at 8:54 pm.

#### **OPENING/CALL TO ORDER**

Jodi Patton, Chair called the meeting to order at 7:01. Ryan Nicoll gave the opening prayer. Jodi then led the Board in a community building exercise by asking what we liked to do individually in the fall. There was then a sharing of joy and pastoral concerns.

#### **APPROVAL OF July 22, 2020 MINUTES**

Steve Mushrush made a motion to approve the minutes. It was seconded by Cydney Philbin and passed unanimously.

#### **REFLECTION/ANNOUCEMENTS**

Jodi discuss her current reflections about embracing change and challenged the Board to think about change and how best to be comfortable with change. She then thanked the Board members for their gifts to celebrate Susan Langer's ordination. She read a thank you note from Susan. Jodie also thanked the Board for their participation in the Bridge supplemental operating gift campaign. Paul Anderson was asked to give a quick update on the matching gift.

Jodie then reviewed the calendar changes with the Board, pointing out the combination of the November and December Governing Board meetings and a Christmas celebration in December.

#### REPORTS

Cydney Philbin gave a brief report on the Personnel Committee that met at 6:00, prior to this meeting. She mentioned the safe church policy that will be sent to the Board in early October. The plan will be to discuss this policy in our October meeting.

Glen Miles gave a brief update to his written report. He mentioned how good it was to be doing his bible study with members of the congregation present. He mentioned that worship will be online only through the end of October. This is something that senior leadership is continually monitoring.

Paul Anderson then updated his written report by discussing the financial results from August, the 2021 budget process, and an update on the Akita cabin construction. He then discussed the 2020 housing



allowance. A motion was made (see attached) by Steve Mushrush and seconded by Cydney Philbin to approve the ministerial housing allowances. The motion passed unanimously.

#### **UNFISHED BUSINESS**

**Governance Review-** Jodie opened the discussion by reviewing the process to date on the 2019 revisions to the constitution. The newly constituted Committee has met twice to review the 2019 revisions and plan to meet once more time to finalize any revisions. The Board had been previously encouraged to review the documents on the First Community website. A brief discussion led by Cydney Philbin was held and any questions of the Board were discussed.

**2020 Strategic Plan** - Jodie reminded the Board that the strategic planning weekend will be held March 6 and 7<sup>th</sup> of 2021. Jodi then announced that Cydney Philbin will be chair of the Governing Board and will be taking an active role in the strategic planning process. Pam Shisler will lead the Planning Committee, all of whom have agreed to stay involved.

#### **NEW BUSINESS**

**Foundation Board** - Alice made the motion, which was second by Dick Wood, Jr. to approve David Nickel as a member of the First Community Foundation Board. It passed unanimously.

**Stewardship 2021: Faithful, Hopeful and Loving -** Molly Hagkull gave a presentation on the 2021 Stewardship Campaign. She talked about why she gives and how Faithful, Hopeful and Loving is embodied in her family. Board members were encouraged to submit their pledge by October 1<sup>st</sup>.

**Nominating Committee Candidate Process Update** – Jamie Green gave a brief update on the process for selection of candidates for the Nominating Committee. Approval of a slate will occur in our October meeting.

**Other** – Alice made a comment about our strong momentum we had prior to the pandemic and encouraged us to have the strategic planning in March. It will be helpful to have some indication of the strategic planning process to be able to adequately prepare the 2021 budget. Jodie is talking with Sarai Rice, our consultant, about some preliminary work this fall. A discussion followed about the outlook for 2021 and how do we embrace the once church concept considering the passion that is embraced by members towards specific ministries and programs.

#### CLOSING

Jodi asked for any final remarks. Cydney Philbin made a comment on the great discussion tonight. Dr. Miles echoed that comment and then led the Board in a closing prayer. Jodi Patton then declared the meeting adjourned at 8:29.



# What Makes a GOOD BOARD MEMBER?

While all effective board members understand and meet their basic responsibilities, truly exceptional board members do more. They go beyond the basics and pay attention to *how* they approach board service. These six characteristics build on straightforward board duties and focus on key traits of exceptional board members.



The partnership between a nonprofit's board chair and CEO is one of the most important elements of a strong board and a successful organization. However, developing this relationship takes work and commitment from both individuals.

The role of chief executive can be lonely, so having a trusted colleague in the board chair is invaluable. A good board chair ensures lines of communication are open and serves as a much-needed sounding board for the CEO.



**Don't Do:** Board chairs shouldn't shy away from, or overreact to, bad news. A strong board chair–CEO relationship is built on trust. The CEO should be just as comfortable sharing bad news as good.



To encourage robust discussion during board meetings, board members must be prepared to listen as well as engage. Exceptional board members are careful not to dominate discussions and ensure that everyone, including quieter board members, have a chance to share their opinions. Additionally, it is important to understand the reasoning behind individuals' comments, even when board members do not agree. After listening carefully to others' views, the board can work together to build consensus.



**Don't Do:** Avoid creating a homogenous board in which consensus is based solely on similar experiences and opinions. Diversity enhances decision making, so

incorporating a number of different perspectives in discussions helps the board arrive at the best result.

## UNDERSTAND THE BALANCE BETWEEN GIVING THE CEO AMPLE ROOM TO MANAGE THE ORGANIZATION AND ENSURING THAT ETHICAL STANDARDS ARE MET.

Board members are overseers, not implementers. The chief executive is in charge of managing the day-to-day activities of the organization, and the board should be careful not to <u>micromanage</u>. Instead, board members are responsible for bringing complex, big-picture questions and opportunities to the organization.

However, the board must also ensure adherence to legal standards and ethical norms. Adopting a "hands-off" management approach does not mean that board members can turn a blind eye to ethical improprieties. All board members should be familiar with the organization's bylaws and understand how best to respond to any ethical issues that might arise.

#### Don't Do:

When introducing issues or programs for the board

to consider, board members should be careful not to push their personal agendas. The needs of the organization should always come before personal connections and pet projects.



ASK "NAÏVE" QUESTIONS THAT OTHERS WANT TO ASK BUT MAY SHY AWAY FROM. One of the most important roles of nonprofit board members is to ask questions. The board should constantly assess current and proposed projects to ensure they serve the organization's mission and are setting the organization up for success.

In addition to bigger picture questions, exceptional board members are not afraid to ask what may seem to some as simple, more straightforward questions as well. Oftentimes, a more nuanced organizational business practice can take time to understand, or a new board member might not be familiar with the organization's history. Good board members are not afraid to ask naïve questions because they trust their own instincts and want to improve their knowledge of the organization.



**Don't Do:** While asking questions is beneficial, board members must be prepared for rigorous discourse by reading all the materials provided to them during new board member orientation and in advance of a board

meeting. Posing a question that has been answered in the materials provided may show a lack of attention or interest.

## SERVE AS AMBASSADORS FOR THEIR ORGANIZATIONS AND UNDERSTAND THE RESPONSIBILITY THAT COMES WITH THAT ROLE.

As ambassadors, board members represent the board outside the boardroom. This can range from talking with colleagues and friends about the good work the organization does to attending meetings with legislators. Board members serve as a link between the organization and its members, stakeholders, constituents, and clients and are responsible for educating influencers and the community about the importance of the organization's work. **Don't Do:** While it is important to discuss the organization's work outside of the boardroom, board members must be careful not to gossip about confidential matters. No matter how informal the situation might seem, internal matters of the organization should remain just that — internal.



Above all else, good board members enjoy their role. They are passionate about the work of the organization and interested in learning more about its mission and the community served. Board meetings should not be seen as a chore; instead, they can help board members connect with their peers and maintain enthusiasm for their important responsibilities.

REMAIN ENERGETIC IN LEARNING ABOUT AND HELPING THE ORGANIZATION.




**Don't Do:** Be wary of board members who have lost their excitement for board service. Occasionally, fatigued or irritable

board members are be a sign of problems with the staff or board processes, but a lack of enthusiasm might also mean it is time for certain members to roll off the board.

- 4. A Town Hall meeting, most likely on Zoom, will be advertised for a November date, as part of this informative letter. Congregants will be asked to email questions in advance of the meeting, to be discussed during it. This will allow the 46 new members of the Congregation to hear about the

changes that were approved by the Governing Board and discussed with the Congregation last winter.

5. The Constitutional changes will be voted on at the annual meeting, January 30, 2021.
