 programs on the 7 Keys and several other offerings are available. We continue to
 evaluate the safety of in person worship with the possibility of one service,
 following strict protocols, on Sunday mornings.
- 3. The church continues to be financially stable. Results are being watched very closely, and we continue to evaluate every expense, including personnel costs. Financial reports and the Board packet are on the website at https://fcchurch.com/boardnews/ within a few days of the Board meeting.
- 4. With the matching gift to the Bridge, we could come very close to break even. Members are encouraged to participate if they are financial able to do so. As of the Board meeting, \$22,722 has been given. Look at the weekly Wednesday email for updates. The 2021 stewardship campaign will begin in October with Board and committee leadership being encouraged to get their pledge in by October 1st.

OPENING/CALL TO ORDER

Jodi Patton, Chair called the meeting to order at 7:01. Ryan Nicoll gave the opening prayer. Jodi then led the Board in a community building exercise by asking what we liked to do individually in the fall. There was then a sharing of joy and pastoral concerns.

APPROVAL OF July 22, 2020 MINUTES

Steve Mushrush made a motion to approve the minutes. It was seconded by Cydney Philbin and passed unanimously.

REFLECTION/ANNOUCEMENTS

Jodi discuss her current reflections about embracing change and challenged the Board to think about change and how best to be comfortable with change. She then thanked the Board members for their gifts to celebrate Susan Langer's ordination. She read a thank you note from Susan. Jodi also thanked the Board for their participation in the Bridge supplemental operating gift campaign. Paul Anderson was asked to give a quick update on the matching gift.

Jodi then reviewed the calendar changes with the Board, pointing out the combination of the November and December Governing Board meetings and a Christmas celebration in December.

REPORTS

Cydney Philbin gave a brief report on the Personnel Committee that met at 6:00, prior to this meeting. She mentioned the safe church policy that will be sent to the Board in early October. The plan will be to discuss this policy in our October meeting.

Glen Miles gave a brief update to his written report. He mentioned how good it was to be doing his bible study with members of the congregation present. He mentioned that worship will be online only through the end of October. This is something that senior leadership is continually monitoring.

Paul Anderson then updated his written report by discussing the financial results from August, the 2021 budget process, and an update on the Akita cabin construction. He then discussed the 2020 housing

allowance. A motion was made (see attached) by Steve Mushrush and seconded by Cydney Philbin to approve the ministerial housing allowances. The motion passed unanimously.

UNFISHED BUSINESS

Governance Review- Jodi opened the discussion by reviewing the process to date on the 2019 revisions to the constitution. The newly constituted Committee has met twice to review the 2019 revisions and plan to meet once more time to finalize any revisions. The Board had been previously encouraged to review the documents on the First Community website. A brief discussion led by Cydney Philbin was held and any questions of the Board were discussed.

2020 Strategic Plan - Jodi reminded the Board that the strategic planning weekend will be held March 6 and 7th of 2021. Jodi then announced that Cydney Philbin will be chair of the Governing Board and will be taking an active role in the strategic planning process. Pam Shisler will lead the Planning Committee, all of whom have agreed to stay involved.

NEW BUSINESS

Foundation Board - Alice made the motion, which was second by Dick Wood, Jr. to approve David Nickel as a member of the First Community Foundation Board. It passed unanimously.

Stewardship 2021: Faithful, Hopeful and Loving - Molly Hagkull gave a presentation on the 2021 Stewardship Campaign. She talked about why she gives and how Faithful, Hopeful and Loving is embodied in her family. Board members were encouraged to submit their pledge by October 1st.

Nominating Committee Candidate Process Update – Jamie Green gave a brief update on the process for selection of candidates for the Nominating Committee. Approval of a slate will occur in our October meeting.

Other – Alice made a comment about our strong momentum we had prior to the pandemic and encouraged us to have the strategic planning in March. It will be helpful to have some indication of the strategic planning process to be able to adequately prepare the 2021 budget. Jodi is talking with Sarai Rice, our consultant, about some preliminary work this fall. A discussion followed about the outlook for 2021 and how do we embrace the once church concept considering the passion that is embraced by members towards specific ministries and programs.

Jodi asked for any final remarks. Cydney Philbin made a comment on the great discussion tonight. Dr. Miles echoed that comment and then led the Board in a closing prayer. Jodi Patton then declared the meeting adjourned at 8:29.

Akita Council Governing Board Update

The Akita Council and their current conversations are looking a bit different these days. Without traditional summer camp this summer the council was significantly less busy over the summer but by no means dormant.

As we have heard in other GB communications Akita moved online with "Sweet Home Camp Akita" This, successful program concluded with another virtual gathering on what would have been the last night of Family Camp and was well "attended". Based on the success of the virtual summer camp Sarah Kientz and the Akita team have been hard at work creating "Akita Weekends" in place of what would normally be retreats at Akita this Fall. These virtual gatherings will continue to bring the Akita Spirit into homes during age appropriate zoom sessions, with Akita style challenges, prizes and of course the staff everyone knows and loves.

Even though the Akita Council was not able to volunteer for summer camp check-ins and returns this summer that did not stop their desire to help out. With the help of the full-time camp maintenance staff, several projects at Akita have been completed by this wonderful group of volunteers. We started with building a new bridge to the far field and last weekend a group was power washing, painting and staining decks and porches of the rental cabins. Government mandated numbers for group gatherings limited the scope of what projects were possible, but Hocking County has recently relaxed on these restrictions and more projects are scheduled this fall.

The Memorial cabin continues to take shape and got its roof this past week. The council continues to look at the long term vision of what Akita should be and the facilities and infrastructure that it will need to carry out it's mission.

The Akita staff has also been working hard at revamping the Akita Store and have had good success with several new products that have been very popular. You can check out the store at www.campakita.org/akitastore


Finally, like with other all other departments at FCC, Akita is working on their 2021 budget. They are looking at multiple scenarios for budgeting, including: a) no summer camp; b) summer camp at 80% capacity; c) summer camp at 50% capacity. With so many unknown factors and anticipating that some restrictions will still be in place next year, budgeting will be challenging. Additional expenses will need budgeted for summer camp cleaning and PPE/medical supplies. All aspects of camp operations, including year-round and summer camp, will be evaluated over the coming months.

This loving group of volunteers is always hard at work and you can see their passion for Akita even thru a computer screen. They doing all they can to support the Akita staff and leave Akita better than they found it.

Meeting Minutes

1. Changes to Governance Review Committee

Cydney Philbin will take over as Chair. Jodi Patton will consult and assist with Town Hall Meetings. Steve Mushrush joined the committee, so that each GB class is represented.

2. Review of February 6, 2020 Minutes

3. Old Business

All new changes were thoroughly reviewed by Counsel. The final recommendations of the GRC were presented to the GB on 2/19/2020. The GB voted and approved these changes to the Constitution. A notice was sent to the congregation on 3/3/20 to explain the need for the Special Meeting to be held on 3/29/2020 to vote on the Proposed Constitution Amendments. The new FC membership brochure was also sent to delineate membership qualifications. Then mid-March the special meeting was canceled due to the Covid-19 pandemic.

4. Governance Review Committee Continuation

The committee was resurrected today to continue the work from March 2020. The committee began to review the Proposed Constitution Amendments in light of the current times. The committee is charged with making recommendations to the GB at the September 23 meeting. A possible vote for GB support of the proposed changes may occur at the October 28 meeting. If so, Town Hall meetings will be planned for the congregation online and hopefully in person. The hope is that the Proposed Constitution Amendments can be voted on at the Annual Meeting January 30, 2021 at 10 am.

5. FAQ

Using the FAQ posted on the FC website under Constitutional Changes, the committee reviewed the purpose for the Constitutional changes, the sources and the individual changes in detail.

6. Next Steps

The Governance Review Committee will meet Monday, September 21,2020 at 12:00 pm by Teams. The purpose will be to thoroughly discuss each of the six changes and to determine if there needs to be any additional changes in light of the pandemic. If possible, the recommendations of the GRC will be presented to the GB on September 23, 2020.

MEETING MINUTES

1. Review of the proposed changes to the Constitution.

The committee reviewed and discussed each of the changes that had previously been voted on and approved by the Governing Board. The committee felt that after extensive research and discussion with the GB and Congregation last year, the changes were still consistent with church practices and appropriate relative to the pandemic. The committee unanimously approved recommending these changes to the GB.

2. Major Changes

Article IV, Section 2 – Reducing the number of Governing Board members from 17 to 14

Article V, Section 1 – Clarification of Senior Minister's responsibilities, including he or she consult with the Chair of the Governing Board or the Executive Committee of the Governing Board if the Senior Minister is proposing the hiring or termination of an ordained person or the Executive Director of Operations

Article VII- Adjusting the Treasurer position to be voted in by the Governing Board

Article VIII – Nominating Committee to be better representative of the congregation

Article III, Section 7 – Requires a vote of the Congregation if the Governing Board is proposing selling a property owned by First Community

Minor changes primarily correcting punctuation/ grammar and substantive consistency

3. Next Steps

The GRC is prepared to discuss questions or concerns with the Governing Board on Wednesday, September 23, 2020. The GRC hopes to have a vote on the Constitutional changes at the GB meeting October 28, 2020. The GRC will then plan Town Hall meetings, and digital and paper communications with the Congregation in preparation for the vote on the Constitutional update at the Annual Meeting January 30, 2021 at 10 am.

4. By-laws

The GRC will next review the GB By-Laws with respect to the Constitutional changes to see if any update is needed in procedure, especially in relation to the pandemic.
